ORDER :

In accordance with section 68 (1) of the Juvenile Justice (Care and Protection of Children) Act, 2000, the Government have issued the Andhra Pradesh Juvenile Justice (Care & Protection of Children) Rules, 2003 in the G.O. 1<sup>st</sup> read above. According to Sub-Section (1) of Section 29 of the Juvenile Justice (Care and Protection of Children) Act, 2000 (Central Act 56 of 2000), the State Government, by notification in the Official Gazette, shall constitute, for a district or a group of districts specified in the notification, one or more Child Welfare Committees for exercising the powers and discharging the duties conferred or imposed on such Committees in relation to the children in need of care and protection under the said Act.

2. Government in G.O. 2<sup>nd</sup> read above, have constituted four (4) Child Welfare Committees for Hyderabad, West Godavari, Kadapa and Vishakaptnam districts for a term of 3 years. Later Government in G.O. 3<sup>rd</sup> read above, have constituted the Child Welfare Committees in the remaining (19) districts. The term of the Committees was extended upto 31-12-2010 vide G.O. 6<sup>th</sup> read above.

3. In G.O. 7<sup>th</sup> read above, Government have constituted a Selection Committee for selection of Chairperson and Members of Child Welfare Committees and Social Worker Members of Juvenile Justice Boards in 23 districts of the State. Whereas in G.O.5<sup>th</sup> read above, the Government, have issued orders authorising the Director, JW,CS & WSC to issue Notification and to invite applications from the eligible persons who fulfill the qualifications and the eligibility criteria prescribed by the Government.

4. In the letter 8<sup>th</sup> read above, the Director, JWCS & WSC, Hyderabad while furnishing the panel of persons recommended to be Chairpersons and Members of Child Welfare Committees by the selection Committee and requested for constitution of the Committees.

5. Government after careful examination of the said proposals of the Director, Juvenile Welfare, Correctional Services & Welfare of Street Children, Hyderabad and in order to implement the provisions of the Juvenile Justice (care and protection of children) Act, 2000 hereby constitute the Child Welfare Committees for each of the Districts in the State with the jurisdiction of each Child Welfare Committee. The Director, Juvenile Welfare, Correctional Services and Welfare of Street Children, Hyderabad shall train the members and functionalise the Committees

6. Accordingly, the following Notification will be published in the next issue of the Andhra Pradesh Gazette:

### **NOTIFICATION**

In exercise of the powers conferred under Sub-Section (1) of Section 29 of the Juvenile Justice (Care and Protection of Children) Act, 2000 (Central Act 56 of 2000), the Governor of Andhra Pradesh hereby constitute the Child Welfare Committees with the persons mentioned in Columns (2) & (3) of the Table below for a period of three years from the date of issue of the notification for exercising the power and discharging the duties imposed on such Committees under the Juvenile Justice (Care and Protection of Children) Act, 2000 and the Rules made thereunder, with the jurisdiction of the districts mentioned in column (4) thereof.
