ORDER :

In accordance with section 68 (1) of the Juvenile Justice (Care and Protection of Children) Act, 2000, the Government have issued the Andhra Pradesh Juvenile Justice (Care & Protection of Children) Rules, 2003 in the G.O. 1<sup>st</sup> read above. According to Sub-Sec (1) of Section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2000 (Central Act 56 of 2000), the State Government by notification in the Official Gazette shall constitute, for a district or a group of districts specified in the notification, one or more Juvenile Justice Boards for exercising the powers and discharging the duties conferred or imposed on such Boards in relation to the Juveniles in conflict with law, under the said Act.

2. Government in G.O.Ms.No.29, Women Development, Child Welfare & Disabled Welfare Department, dated: 06-12-2004 have constituted nine (9) Juvenile Justice Boards with the Judicial Magistrate of 1<sup>st</sup> class nominated by the Registrar General, A.P.High Court as Principal Magistrates of the Boards for Hyderabad, Warangal, Nizamabad, Krishna, East Godavari, Vishakapatnam, Chittoor, Ananthapur and Kurnool districts for a term of 3 years. Later Government vide G.O.Ms.No.19, Women Development, Child Welfare & Disabled Welfare Department, dated: 11-08-2006, constituted (14) Juvenile Justice Boards for remaining districts. The term of the Boards was extended vide G.O.Ms.No.25, Women Development, Child Welfare & Disabled Welfare Department, dt.06-10-2009 for a period of 3 months upto 31-12-2009. Subsequently, the term of Boards was extended upto 30-03-2010 and 30-06-2010 vide G.O.Ms.No.4, Women Development, Child Welfare & Disabled Welfare Department, dated 28-01-2010 and G.O.Ms.No.10, Women Development, Child Welfare & Disabled Welfare Department, dated 30-03-2010, respectively. Lastly, Govt. vide G.O.Ms.No.43, Women Development, Child Welfare & Disabled Welfare Department the term was extended upto 31-12-2010.

3. In G.O.3<sup>rd</sup> read above, Government have constituted a Selection Committee for selection of Chairperson and Members of Child Welfare Committees and Social Worker Members of Juvenile Justice Boards in 23 districts of the State for a period of 6 months. Whereas in G.O. 4<sup>th</sup> read above, Government have issued orders authorising the Director, Juvenile Welfare, Correctional Services & Welfare of Street Children to issue notification and to invite applications from the eligible persons, who fulfill the qualifications and the eligibility criteria prescribed by the Government.

4. In the letter 6<sup>th</sup> read above the Director, Juvenile Welfare, Correctional Services & Welfare of Street Children, Hyderabad while furnishing the panel of persons recommended to be Social Worker Members of the Juvenile Justice Board by the selection Committee and requested for constitution of Boards.

5. The Government after careful examination of the said proposal of the Director, Juvenile Welfare, Correctional Services & Welfare of Street Children, Hyderabad and in order to implement the provisions of the Juvenile Justice (Care and Protection of Children) Act, 2000 hereby constitute Juvenile Justice Boards for each of the District in the State and the jurisdiction of each Juvenile Justice Board.

6. Accordingly, the following notification will be published in the next issue of the Andhra Pradesh Gazette:

#### **NOTIFICATION**

In exercise of the powers conferred by Sub-Sections (1) and (2) of Section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2000 (Central Act 56 of 2000) read with clause (J) of Section 2 and Sub-Section (1) of Section 11 of the Code of Criminal Procedure, 1973 (Central Act II of 1974), the Governor of Andhra Pradesh hereby constitutes the Juvenile Justice Boards consisting of the Principal Magistrate nominated by the High Court of Andhra Pradesh in Column (2) and the Social Worker Members mentioned in column (3) of the Table below for a period of three years from the date of issue of the notification for exercising the power and discharging the duties imposed on such Boards under the Juvenile Justice (Care and Protection of Children) Act, 2000 and the rules made thereunder with Jurisdiction of the districts mentioned in column (4) thereof:
